WARDEN REPORT:

Warden Janine Quigley spoke about the CCAP Task Force for Comprehensive Behavioral Health issues. The task force will be meeting for the next six months to form an action plan and comprehensive plan. The information will be presented to CCAP members at the annual meeting in an effort to work with the State on substance abuse and mental health issues in the jail system.

The County was accepted into the Stepping Up Initiative event in Washington, DC that five team members from Berks County will be attending in April, 2016.

The Warden reported that the number of state technical parole violators in the jail is currently 73.

JAIL SENIOR STAFF REPORTS:

Chief Deputy Warden Jeffrey Smith reported the staffing update: Five cadets are currently in the academy and are scheduled to graduate April 12, 2016. Correctional officer testing is scheduled for March 18, 2016. There are five correctional officer vacancies.

- Conditions Assessment Several recommendations to make changes within the report were made to CDI Kimball to review.

- Video Visitation Prototype Sign-on information is pending. The pilot has been tested resulting in minor audio issues. Information is being gathered to determine which units will start the program.
- Infrastructure and Security: Architect sent letters to various subcontractors to complete work and punch list items.

A discussion took place concerning the location of private meeting areas for attorneys to meet with inmates.

The Warden reported that the C2 housing unit for juveniles will be ready by May. The PREA audit is scheduled for June 29, 2016.

Deputy Warden Stephanie Smith reported that the computer based GED testing is now running.
