



Sheriff Eric J. Weaknecht has been a member of the Berks County Sheriff's Office since 1984.

The Berks County Sheriff's Office is staffed with 108 full time employees, operates a fleet of 30 vehicles and occupies three floors of the Berks County Courthouse. The Sheriff's Office is responsible for elements of both criminal court and civil court and has a licensing issuance and enforcement function. The Sheriff's Office service area not only includes Berks County, but is required to travel the Commonwealth of Pennsylvania and the entire United States. It services tens of thousands of civil customers across our counter and in the county, and it handles over 12,000 criminal defendants. The Sheriff's Office is organized into six divisions: Civil, Court, Patrol, Central Booking, K-9, and Warrants.

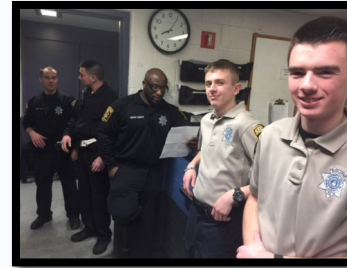

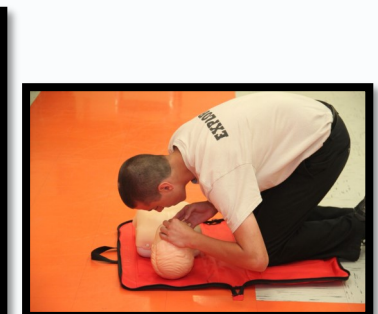
