# BERKS COUNTY PRISON BOARD MINUTES OCTOBER 11, 2023

#### **JAIL SENIOR STAFF REPORTS**

INMATE POPULATION: Warden Jeffrey Smith stated the inmate population is 787. Two juveniles at Lehigh County and 3 juveniles at Wayne County. Forty-two inmates are sentenced to an SCI. Twenty-six inmates are ready to be transported between now and October 26th. Thirteen inmates are awaiting a transport date. Three inmates are pending due to other circumstances.

PROJECT UPDATES: Warden Smith updated the board that the current projects:

- Replacing some of the showers with stainless steel inserts as part of the capital plan.
- New washer and dryer installs in main laundry is complete just need to connect steam and exhaust lines.
- Roof conduit repair is still being worked on. Should be done by end of November.
- Maintenance team is doing exterior repairs on the mansion waiting on contractor to do the dormers, windows, roof (Bond issues)
- Community Service project last week at Maiden Creek Township brush pick up and shredding
  - Yesterday trash clean up in Exeter Township.

STAFFING: Deputy Warden Roberts updated the Board on the status of the staffing:

- 32 Correctional Officer vacancies
- 6 Sergeant vacancies
- 4 Cadets in the Academy with a tentative graduation date of December 21<sup>st</sup>.
- Next scheduled testing on October 23rd

PROGRAMS: Deputy Warden Smith updated the Board on programing. There are currently 86 D roster inmates in population. Last month there were 13 inmates for eligible for work release.
