Minutes from the August 31, 2022 Meeting

The Berks County Agricultural Land Preservation Board (Board) held a regular monthly meeting on Wednesday, August 31, 2022, at 7:00 PM via virtual platform "Microsoft Teams." David Phillips, Chair, called the meeting to order at 7:01 PM. Board members present included James Coker, Gregg Eshelman, Morgan Firestine, Kimberly McGrath, Steven Mohn, Louise Swartley, and David Phillips. Clyde Myers joined during the meeting. Also, in attendance were Mark Sprow, Esq. Special Counsel for the Board; Staff: Amanda Burkard-Sell and Kimberly Fies; Emily Wangolo, Deputy Director; and Tami Hildebrand, Executive Director.

I. PUBLIC COMMENTS ON AGENDA ITEMS – None.

II. APPROVAL OF MINUTES

Motion: A motion was made to approve the minutes of the July 27, 2022, meeting, as drafted. (L. Swartley, M. Firestine)

Vote: Motion carried unanimously.

- Hildebrand informed the Board that the deadline for the landowner of Docket #0336 had passed but that the landowner had been in communication with staff and the County's Assistant Solicitor, David Peris, Esq. and that the issue is currently being worked on.

B. No Update: Soil Health Education Grant Workshop

• T. Hildebrand reported that there was no further update on the Soil Health Education Grant Workshop.

C. No Update: Settlement #432.0 Swinsinski – ACE Program Violation

• T. Hildebrand reported that Attorney Sprow had provided a draft letter for review and that the letter was reviewed and will be sent to the landowner.

D. Update: Settlement #517.0 Schwegmann – ACE Program Violation

- T. Hildebrand reported that the letter that had been sent by Attorney Sprow did not expressly state that the farm was in violation of the easement. Hildebrand added that the landowner had responded with a letter in which she stated that she did not agree with the content of the Solicitor's letter in that she felt that she was not contacted multiple times regarding the issue. Hildebrand added that the issue still has not been addressed with a corrective deed and suggested that Attorney Sprow send a second letter confirming that the farm was in violation and that the issue must be addressed.
- G. Eshleman also offered to personally contact the landowner to discuss the issue.
- The Board agreed that both courses of action should be taken.

 - Hildebrand added that on August 24, 2022, Berks County had settlement on the 800th farm to be preserved in the County and thanked the Board for their participation in achieving this milestone.
